

- 1. Hereby Releases, Waives, Discharges and Covenants Not To Sue Prairie Winds Aikido, Grand Marais Aikikai, Aikido NW Minnesota, Aikido of Minnesota or Shuharikan and/or each of its instructors or officers, employees and agents all for purpose herein referred to as Releasees, from liability to the Undersigned, his/her personal representatives, assigns, heirs and next of kin for all loss or damage and any claim or demands therefore, on account of injury to the person or property or resulting in death of the Undersigned, whether caused by the negligence of Releasees or otherwise while the Undersigned is upon the premises of Prairie Winds Aikido or Morris Area Schools herein referred to as Seminar Dojos, and/or a participant in seminar classes, workouts, or events, and
- 2. Hereby Agrees To Indemnify And Save And Hold Harmless the Releasees and each of them from any loss, liability, damage, or cost they may incur (1) due to the presence of any action of the Undersigned in or about Seminar Dojos and/or (2) due to participation in classes or workouts whether caused by the negligence of the Releasees or otherwise.

- 3. That the Undersigned participant gives consent to whatever medical care might be provided or available on the premises and further agrees to conform and comply with all the rules and regulations of the Seminar Dojos .
